

Q Lever handle DG 58.S216.AL.SS PZ 92


greenteQ lever handles for house front doors made of plastic.

Properties:

The greenteQ lever handle DG 58.S216.AL.SS PZ 92 is made of aluminium and has a plate width of 35 mm. The handle is prepared for a profile cylinder, with a spacing of 92 mm. The levers are mounted in such a way that they are stationary/rotatable and have a holding spring. The greenteQ lever handle DG 58.S216.

AL.SS PZ 92 is preconfigured for an 8mm square spindle. The outer plate has supporting cams and is fixed in place by means of a concealed screw connection, for which a separate accessories set (3 x M6 screws, 1 x 8 mm square spindle) is required.
